Down East Spring Round Up

Deputies arrest numerous drug suspects following undercover drug operations

"This has been a very effective undercover operation conducted by our drug detectives. The drug crimes committed by these suspects range from misdemeanor possession to felonious drug trafficking. Some of these offenders have been selling drugs for quite some time and some are repeat offenders" said Sheriff Asa Buck.
