Drug Dealers Out on Bond Arrested by Sheriff and Police

Lamar Rodericas Teel AKA "Boo Boo", 27, and Steven Orlando Wilson, AKA "Tony", 30, both of James Grady Rd, Newport were arrested on June 28th by Carteret County Sheriff and Morehead City drug detectives on numerous drug charges. This is the second time in six months that these suspects have been arrested by detectives on numerous counts of drug offenses committed in Carteret County.



At the time of their arrest the two suspects were out on bond and awaiting trial due to a previous drug arrests by Sheriff's drug detectives back on December 31st 2010. At that time the two were charged with numerous counts of selling marijuana and cocaine. Teel and Wilson received \$200,000 and \$100,000 bonds respectively which according to Sheriff Asa Buck only held them in jail for approximately 3 hours until they made bond through a local bondsman.



Sheriff Buck stated "After these suspects posted their bonds our detectives continued to receive information that Teel and Wilson were still engaged in illegal narcotics sells. Our detectives targeted these suspects again and began undercover operations. Teel and Wilson were arrested at Frank's Pizza on Highway 24 which we suspect was being used as one of their bases of operation due to the fact that they were conducting their drug transactions in the parking lot of this business. A search of Teel and Wilson's vehicle resulted in the seizure of 139 grams of Marijuana, 5 grams of Cocaine and 1 gram of Ecstasy."

Teel and Wilson were arrested and transported to the Carteret County Jail. Teel received a \$500,000 secured bond and Wilson received a \$400,000 secured bond.
