9 Drug Dealers Busted in Beaufort

On 9-15-2011 Deputies and Officers from the Carteret County Sheriff's Office, Beaufort and Morehead City Police Departments arrested several suspects in the Beaufort area and charged them with numerous drug charges. During recent months Detectives conducted an undercover drug investigation into a ring of drug dealers operating in the Beaufort area. These suspects live and/or conduct their drug operations in the Beaufort community. This investigation took several months and more arrest will follow.
